# Integrated Approaches to HIV Care and Prevention in the Midwest

February 27-28, 2024

The Midwest Learning Symposium is a learning collaborative led and facilitated by CDC-funded Midwest Technical Assistance (TA) providers San Francisco Community Health Center, Washington University in St. Louis, and AIDS United. The purpose of this symposium is to bring together the HIV workforce and provide opportunities for peer-to-peer learning, networking, and innovative problem-solving in clinical routine opt-out HIV testing and linkage to care (LTC), implementation of PrEP services in rural communities, and diverse approaches to social determinants of health, using scalable, high-impact syndemic strategies in the Midwest Region. This two-day hybrid symposium will convene to build the capacity of health departments, community-based organizations (CBOs), and clinical providers both in person and virtually through presentations, panel discussions, and workshops.

#### After attending the Midwest Learning Symposium, participants will:

- 1. Identify two promising practices for implementing and sustaining clinical routine opt-out HIV testing models based on the exemplary services that have been implemented at various clinical sites located in the Midwest and that can be applied to their own testing programs.
- 2. Identify five peers in the Midwest who have implemented innovative PrEP services that address syndemics in the Midwest region, prioritize rural populations, and apply at least two lessons learned to their own PrEP program.
- 3. Define syndemics and increase participant understanding of syndemic approaches by reviewing three steps used to identify syndemics in conjunction with social elements; and five strategies for integrating syndemic theory into their public health work.

Session Summary: Transgender women of color continue to be disproportionately affected by HIV. This moderated panel discussion with Midwest identity consultants of transgender experience will delve into integrated services for HIV, sexually transmitted infections (STIs), and other co-occurring healthcare needs. Panelists will share their expertise on transgender women and discuss how organizations can address barriers to quality services. During an interactive Q/A segment, the audience will be invited to share their real-world challenges and learn strategies from the panel that they can take back to their organizations to implement change.

- 1. Describe at least two integrated health services needed by transgender women.
- 2. List at least three barriers to healthcare that disrupt integrated health services for transgender women.
- 3. Identify at least one promising practice to engage transgender women in care.
- 4. Cite at least two CDC resources to help their organization as they provide comprehensive services for transgender women.

Session Summary: This moderated virtual panel discussion with frontline HIV workers

will showcase routine opt-out HIV testing and linkage to care (LTC) models that align with <u>Centers for Disease Control and Prevention (CDC) Revised HIV Testing Recommendations</u>. These models are practiced within clinical settings that sit in diverse Midwest communities with HIV prevalence greater than .01%. Panelists will address promising practices for clinical HIV testing implementation as well as strategies for integrating testing models that screen for infectious diseases beyond HIV.

- 1. Cite at least two routine opt-out HIV testing and LTC models used in clinical settings within the Midwest Region.
- 2. Identify at least two promising practices for implementing and sustaining routine opt-out HIV testing models in clinical settings.
- 3. Identify at least one effective strategy for integrated testing models that screen for infectious diseases and other health concerns beyond HIV within clinical settings.

(Track B) Session Title: Innovative PrEP Programs that Address Syndemics in the Midwest

**Session Summary:** This moderated discussion will present a panel of implementers of innovative PrEP programs that address syndemics affecting rural areas in the Midwest. Topics that will be discussed are TelePrEP, PrEP and SSPs, PrEP and COVID-19, and PrEP referrals from STI screening and rapid HIV self-tests. Questions for panelists will include prepared questions from the Washington University in St. Louis CBA team and questions from participants in the in-person and virtual audience. Participants will gain knowledge and skills on how to adapt and integrate PrEP services to address syndemics in the rural Midwest.

- 3. Apply at least two lessons learned from other PrEP programs that have adapted and integrated health services to address syndemics in the Midwest.

(Track C) Session Title: Approaching Social Determinants of Health Through a Syndemic Lens
